4. The Giftpay offer is available for bookings made on or after 04/08/2025.
5. The Giftpay offer will be provided in the form of a £500 Giftpay Voucher. The voucher will be provided after your 2<sup>nd</sup> rent payment has been made in September/October 2025.
6. If a student chooses to pay their rent in full, the voucher will be distributed within 8 weeks of the tenancy starting.
