

## £300 GiftPay Offer (Silver 2-Bed Apartment) – Nova, Nottingham

### Terms & Conditions

Students who book a Silver 2-bed apartment at Nova, Nottingham for the 2026/27 academic year will receive a £300 GiftPay voucher. This offer is only valid until 3<sup>rd</sup> April 2026 at 23:59pm.

#### 1. Eligibility

**This offer is available to:**

- New bookings for 2026/27, and
- Current in-room residents booking for 2026/27

This offer applies only to Silver 2-bed Apartment room types at Nova, Nottingham.

#### 2. Booking period

- This is a limited time offer, available until **23:59 on 3<sup>rd</sup> April 2026**.
- Bookings must be completed within this period to qualify.

#### 3. How to apply the offer

- Students must enter the incentive code **NOV-2627-300GP** during the booking process.
- The code must be added to the “Incentive” box under the “Incentive, Ambassadors and Agents” section.
- If the code is not entered at the time of booking, the offer cannot be applied retrospectively.

#### 4. What counts as a completed booking?

**A booking is considered complete once:**

- The tenancy agreement has been fully signed by all required parties (including guarantor, where applicable), and
- The student has moved into their room.

#### 5. GiftPay fulfilment

- The offer will be provided in the form of a £300 GiftPay digital voucher, sent to the email address associated with the student’s booking account.
- For students paying their rent by instalments, the voucher will be issued after the second rent payment has been successfully received following the start of the 2026/27 tenancy.
- If a student chooses to pay their rent in full, the voucher will be issued within 8 weeks of the tenancy start date.

#### 6. Additional eligibility checks

- Eligibility must be verified by the General Manager at Nova, Nottingham.
- At the point of reconciliation and voucher processing, the student’s account must have no outstanding rent or other charges.
- If there is any outstanding balance on the account at this time, voucher distribution will be paused and will only proceed once the balance has been cleared in full.

- Where an outstanding balance is not cleared within a reasonable period, Collegiate may, at its discretion, withhold or cancel the incentive.

### **7. Important information**

- Only one giftpay incentive per booking is permitted.
- This offer cannot be combined with any other tenancy-specific offers or financial incentive unless explicitly stated.
- Room availability is first-come, first-served basis, and subject to availability.
- If a booking is cancelled or the student does not move in, the offer will no longer apply.
