

£250 GiftPay Offer – Crown Place, Cardiff

Terms & Conditions

Students who book any room (excluding Premium Studios) at Crown Place for the 2026/27 academic year will receive a £250 GiftPay voucher.

Use code CPC-2627-250GP at the stage of booking.

1. Eligibility

This offer is available to:

- New bookings for 2026/27, and
- Current in-room residents booking for 2026/27

This offer applies to all room types bar the Premium Studio room type at Crown Place.

2. How to apply the offer

- Students must enter the incentive code **CPC-2627-250GP** during the booking process.
- The code must be added to the “Incentive” box under the “Incentive, Ambassadors and Agents” section.
- If the code is not entered at the time of booking, the offer cannot be applied retrospectively.

3. What counts as a completed booking?

A booking is considered complete once:

- The tenancy agreement has been fully signed by all required parties (including guarantor, where applicable), and
- The student has moved into their room.

4. GiftPay fulfilment

- The offer will be provided in the form of a £250 GiftPay digital voucher, sent to the email address associated with the student’s booking account.
- For students paying their rent by instalments, the voucher will be issued after the second rent payment has been successfully received following the start of the 2026/27 tenancy.
- If a student chooses to pay their rent in full, the voucher will be issued within 8 weeks of the tenancy start date.

5. Additional eligibility checks

- Eligibility must be verified by the General Manager at Crown Place, Cardiff.
- At the point of reconciliation and voucher processing, the student’s account must have no outstanding rent or other charges.
- If there is any outstanding balance on the account at this time, voucher distribution will be paused and will only proceed once the balance has been cleared in full.
- Where an outstanding balance is not cleared within a reasonable period, Collegiate may, at its discretion, withhold or cancel the incentive.

6. Important information

- Only one giftpay incentive per booking is permitted.
- This offer cannot be combined with any other tenancy-specific offers or financial incentive unless explicitly stated.
- Room availability is first-come, first-served basis, and subject to availability.
- If a booking is cancelled or the student does not move in, the offer will no longer apply.
