£500 Just Eat Group Booking Incentive

Terms & Conditions

Promoter: Collegiate AC Ltd on behalf of the property landlord.

Eligible residents who complete a qualifying group rebooking at Nova Nottingham for the 2026/27 academic year may qualify for a £500 Just Eat voucher, subject to the following Terms & Conditions.

1. Promotional Offer Overview

- 1.1 Eligible groups of six (6) residents who successfully complete qualifying group bookings at Nova Nottingham between 20 May 2026 and 3 June 2026 will qualify for one (1) £500 Just Eat voucher per group
- 1.2 The promotion is limited to a maximum of four (4) qualifying groups only. Once four eligible groups have been verified and confirmed by Collegiate AC Ltd, the promotion will close automatically.
- 1.3 This promotion applies to both:
 - Current Nova Nottingham residents completing qualifying rebookings; and
 - New customers making qualifying new bookings for the 2026/27 academic year at Nova Nottingham for eligible tenancy lengths of 44 weeks or longer.
- 1.4 The incentive is intended to support friendship and cluster bookings and applies only where all six residents request to live together as part of the same cluster or flat grouping during the booking process.
- 1.5 This promotion cannot be used in conjunction with any other offer, discount, incentive, cashback arrangement, referral promotion, or promotional campaign unless explicitly stated otherwise by Collegiate AC Ltd.

2. Eligibility Criteria

To qualify for the promotion, all members of the group must:

- Be either:
 - Current residents completing a qualifying rebooking; or
 - New customers making a qualifying new booking at Nova Nottingham;
- Complete their booking during the promotional period;
- Clearly provide the names and booking details of the residents they wish to live with during the booking process;
- Successfully complete all stages of the booking process;
- Sign their tenancy agreements in full;
- Pay all required reservation fees;
- Successfully move into the property for the 2026/27 academic year;
- Pay the first rent instalment in full;
- Not be in rent arrears or breach of tenancy obligations (where applicable);
- Maintain the booking through to tenancy commencement.



3. Group Verification

3.1. All group bookings will be manually reviewed and verified by the Nova Nottingham General Manager or authorised property representative.

3.2. To qualify:

- All six residents must have mutually identified each other as part of the same group during booking;
- All six bookings must remain active and valid through tenancy commencement;
- All six residents must satisfy the eligibility criteria outlined in these Terms & Conditions.

3.3 Collegiate AC Ltd reserves the right to reject any group where:

- Group information is incomplete or inconsistent;
- Residents withdraw or cancel bookings;
- Fraudulent, duplicate, or manipulated entries are suspected;
- The group fails verification checks.

4. Incentive Terms

4.1. Each qualifying group will receive one (1) £500 Just Eat voucher only.

4.2. The voucher will be issued to one nominated group member only, as identified and agreed by the group. Collegiate AC Ltd accepts no responsibility for distribution of the voucher between group members once issued.

4.3. The voucher will be issued within 30 days of:

- All six residents successfully moving into the property; and
- The first rent instalment for all group members being paid in full.

4.4. The voucher:

- Is non-transferable;
- Cannot be exchanged for cash;
- Has no cash alternative;
- May be issued digitally or physically at Collegiate's discretion.

4.5. If the stated voucher becomes unavailable for reasons outside Collegiate's control, an alternative incentive of equal or similar value may be substituted.

5. Exclusions

- Groups containing fewer than six eligible residents;
- Residents or customers who cancel and rebook to attempt qualification;
- Incomplete, withdrawn, fraudulent, duplicate, or manipulated bookings;
- Groups failing manual verification checks;
- Bookings made outside the promotional period;
- Residents or customers attempting to secure multiple group incentives through overlapping bookings.

Only one incentive is permitted per qualifying group.

6. General Conditions

- Verify eligibility of all applicants;
- Refuse or revoke incentives where Terms & Conditions are not met;
- Disqualify fraudulent or abusive applications;
- Amend, suspend, or withdraw the promotion where reasonably necessary.
