Terms & Conditions

Students who book a 2 Bed Apartment or Studio Plus room at Crown Place Portsmouth (51 & 44 weeks only) for the 2026/27 academic year will receive a £400 GiftPay voucher.

1. Eligibility

This offer applies to:

- New bookings for the 2026/27 academic year on a 51 or 44-week tenancy.
- 2 Bed Apartment & Studio Plus room types only.

2. How to apply the offer

5. Additional eligibility checks

- Eligibility must be verified by the General Manager at Crown Place, Portsmouth.
- At the point of reconciliation and voucher processing, the student’s account must have no outstanding rent or other charges.
- If there is any outstanding balance on the account at this time, voucher distribution will be paused and will only proceed once the balance has been cleared in full.
- Where an outstanding balance is not cleared within a reasonable period, Collegiate may, at its discretion, withhold or cancel the incentive.

- Room availability is first-come, first-served basis, and subject to availability.
