1. Promotional Offer Overview

Eligible residents studying at the University of Birmingham who make a qualifying booking or rebooking for the 2026/27 academic year at Chamberlain Place will receive free train travel to either the University of Birmingham's Edgbaston or Selly Oak campus, worth up to £300, subject to these Terms and Conditions

Students who select University of Birmingham as their university when completing their accommodation application will automatically be considered for the promotion, subject to meeting the eligibility criteria below. The promotion is limited to the first 20 eligible applicants and will be allocated on a first-come, first-served basis, based on the date a qualifying booking is completed and all eligibility criteria have been satisfied.

This promotion applies to eligible room bookings for the 2026/27 academic year and may be used in conjunction with any other Collegiate AC Ltd promotion, discount or incentive unless otherwise stated.

2. Eligibility Criteria

- Cannot be exchanged for cash or any alternative incentive;
- Has no cash value.

Where the train travel benefit is provided by a third-party rail operator or travel provider, use of the benefit is subject to that provider's own terms and conditions. Collegiate AC Ltd accepts no responsibility for changes, suspension or withdrawal of services by the provider.

If, for operational reasons, the advertised train travel benefit cannot be provided, Collegiate AC Ltd reserves the right to substitute an alternative incentive of equal or similar value.
