

Portsmouth Clearing 2026 – £2,000 Holiday Voucher Prize Draw

Earlsdon Street, Middle Street, St James Street & Crown Place Portsmouth

Terms & Conditions

Promoter: Collegiate AC Ltd on behalf of the participating property landlords.

Students who make a qualifying booking at **Earlsdon Street, Middle Street, St James Street or Crown Place Portsmouth** during the **Clearing 2026 promotional period** will automatically be entered into the Portsmouth £2,000 Holiday Voucher Prize Draw, where **two (2) winners will each receive a £2,000 holiday voucher**, subject to the following Terms & Conditions.

1. Promotional Period

The prize draw will run from **11 August 2026 until 23:59 on 19 October 2026**. Bookings must be made during this promotional period to qualify.

2. Participating Properties

The following Portsmouth properties are participating in this prize draw:

- Earlsdon Street, Portsmouth
- Middle Street, Portsmouth
- St James Street, Portsmouth
- Crown Place Portsmouth, Portsmouth

Qualifying bookings made at any of the four participating properties will be entered into the same Portsmouth prize draw.

3. Eligibility Criteria

To qualify for entry into the prize draw, applicants must:

- Make a new booking or rebooking at one of the participating Portsmouth properties during the promotional period;
- Book a tenancy of **39 weeks or longer** for the **2026/27 academic year**;
- Complete all required stages of the booking process;
- Sign the tenancy agreement in full, including guarantor where applicable;
- Maintain the booking through to tenancy commencement; and
- Move into the property and commence the qualifying tenancy.

The prize draw applies to **all room types**, subject to availability.

Qualifying bookings may be made:

- Directly through the Collegiate website or other approved Collegiate booking channels;
- Through an agent; or
- Through an approved third-party booking provider.

Existing residents who make a qualifying **rebooking** during the promotional period are also eligible. Bookings made before **11 August 2026** will not qualify retrospectively.

4. Prize Draw Entry

Each qualifying booking will automatically receive **one (1) entry** into the Portsmouth Holiday Voucher Prize Draw.

No separate entry form or promotional code is required.

Only one entry is permitted per qualifying tenancy agreement.

All qualifying entries from **Earlsdon Street, Middle Street, St James Street and Crown Place Portsmouth** will be entered into the same prize draw.

5. The Prize

There will be **two (2) winners**.

Each winner will receive **one (1) holiday voucher worth £2,000**.



The total prize value across the Portsmouth prize draw is **£4,000**.

Each prize:

- Has no cash alternative.

If a selected winner cannot be contacted or does not respond within **fourteen (14) days** of the initial notification, Collegiate AC Ltd reserves the right to select an alternative winner at random from the remaining eligible entries.

7. Exclusions

- Tenancy agreements of less than **39 weeks**;
- Bookings made before **11 August 2026** or after **23:59 on 19 October 2026**;
- Cancelled, withdrawn, fraudulent or incomplete bookings;
- Bookings where the resident does not move into the property and commence the qualifying tenancy;
- Applicants attempting to amend, transfer, duplicate or manipulate bookings for the purpose of gaining additional prize draw entries.
