Terms & Conditions

Students who book a Bronze Ensuite room at Bagot Street for the 2026/27 academic year will receive a £500 GiftPay voucher.

Use code BGS-2627-500GP-BE at the stage of booking.

1. Eligibility

- New bookings for 2026/27, and
- Current in-room residents booking for 2026/27

This offer applies only to Bronze Ensuite room types at Bagot Street, Birmingham.

2. Booking period

- This is a limited time offer.
- Bookings must be completed within this period to qualify.

3. How to apply the offer

- Students must enter the incentive code **BGS-2627-500GP-BE** during the booking process.
- The code must be added to the “Incentive” box under the “Incentive, Ambassadors and Agents” section.

4. What counts as a completed booking?

- If a student chooses to pay their rent in full, the voucher will be issued within 8 weeks of the tenancy start date.

6. Additional eligibility checks

- Eligibility must be verified by the General Manager at Bagot Street, Birmingham.
- At the point of reconciliation and voucher processing, the student’s account must have no outstanding rent or other charges.
- If there is any outstanding balance on the account at this time, voucher distribution will be paused and will only proceed once the balance has been cleared in full.

- Where an outstanding balance is not cleared within a reasonable period, Collegiate may, at its discretion, withhold or cancel the incentive.

7. Important information

- Only one giftpay incentive per booking is permitted.
- This offer cannot be combined with any other tenancy-specific offers or financial incentive unless explicitly stated.
- Room availability is first-come, first-served basis, and subject to availability.
- If a booking is cancelled or the student does not move in, the offer will no longer apply.
